Ancestors' Homes

Are you curious about the homes of your ancestors? If you find addresses on historical records like City Directories, Census Records, Deed Records, etc. you can search for them on websites like Zillow, Realtor.com, Trulia, Redfin, and Homesnap.

On Zillow, create an account, search for the address, click on the Save icon at the top of the screen. If something happens for this address you will be notified.

My parents sold the house I grew up in when they moved in 1994. The couple who bought it from them raised their family in the home and sold it in 2018. The pictures are still on Zillow from the 2018 sale so I could see how the house had changed.

The home my grandfather was raised in was built in 1866 by his grandmother's and her first husband. He died and she married my great-grandfather. The house remained in the family for two generations until my great aunts sold it due to failing health in the 1970's. I remember visiting them when I was a little girl. The house was sold again in 2009 and the pictures are still on Zillow from that sale. The current street view shows that the current owners have painted the house and it has been maintained very well.

Sometimes you will find that the home, boarding house or apartment building no longer exists but it is definitely worth a few minutes to search to see.

SS-5 Form

When our ancestors applied for a Social Security Number they completed a SS-5 form. Copies of these forms are available from the Social Security Administration for \$30 using the Freedom of Information Act (FOIA). Requests can be filed online or via mail. Information is available on their website https://foia.ssa.gov/app/Home.aspx



You will have to create an account. SS-5 forms can be ordered for deceased persons who were born over 120 years ago or died at least three full calendar years before the date of the request. Usually these forms were filled out by the applicant so you get information they provided and their signature.

This is a copy of the SS-5 form for John Coakley. It provided information that I wouldn't have known if I didn't order this record.



Birth certificates were not required until the early 1900's in many places. The SS-5 may be the only official document that includes birth information and the name of the applicant's parents. John's birth was not registered in St. Louis. He was baptized in 1903 in New York City. The baptism record includes his date of birth but not birth place. This document confirms his birthplace was St. Louis.

John lost his job as a draftsman in Kansas City, Kansas so he and his wife Helen applied for and were granted a homestead in California in 1927. John had health issues so they moved to a smaller ranch in Fallon, Nevada in 1940. They sold the ranch in 1945. In June of 1946 they purchased a home in Kansas City, Missouri. Based on the information on this record, John and Helen lived in Quincy, Illinois before they settled in Kansas City. Elizabeth's mother died 12 August 1944. The address on the application was her address. This tells me that I need to look for the sale of the property under Helen's name.

No matter what record you are looking at it is critical to understand the record, determine who the informant is, and pay attention to all the information included.

DNA News

MyHeritage has refreshed the data for Theory of Family Relativity adding millions of new theories that can help explain your relationship to DNA matches. Over two million DNA kits now has at least one theory. Here is a <u>link</u> to a blog post with more information.

Family Tree DNA provides Y DNA haplogroups from Family Finder Autosomal Tests—the autosomal DNA processing chips include a limited number of targeted Y and mitochondrial DNA SNP locations. Generally, those locations are haplogroup predictive, which is how haplogroup information can be obtained from the test. Ancestry's DNA database has reached 25 million, the largest autosomal database. They have also refined their communities. There was a communities by parent release in early 2024 and the algorithms and community reference panels were updated to make the results more precise. You may connect to communities you weren't connected to before and you may have lost communities that you had a weaker genetic connection to. Matches are now linked to the communities.
