Theresa Howell, MLIS started her genealogical pursuit with the search for her birth parents over 15 years ago, and she hasn't stopped since. She currently focuses her research on 19th century Texas, Oklahoma, and Arkansas. Theresa is a former board member of the Dallas Genealogical Society. She holds a Master's degree in Digital Libraries from Drexel University. She is employed as a digital content librarian with Baylor Scott & White Health in Dallas and is eagerly looking forward to retiring and devoting her full time to traveling, researching, writing, and speaking. She lives in Plano, Texas.

Treasure Hunting in Texas: The Robert Blake Research Collection

Until well into the 19th century, San Antonio and Nacogdoches were the primary Spanish and Mexican settlements in the area now known as Texas. Large collections of the original official and private documents and civil proceedings from the earliest times of these settlements are preserved in various archives. Robert Bruce Blake spent more than thirty years studying, classifying, and translating these documents. Working in the archives in Nacogdoches and Austin, Blake personally typed the more than thirty thousand pages now organized in seventy five volumes. He died in 1955, leaving the work unfinished. Carrying out his bequest, his wife turned the work over to the UT Library to make the work available to Texas educational institutions. Duplicate copies of the books were placed at the Texas State Archives in Austin, Stephen F. Austin State University in Nacogdoches, and the Houston Public Library. The Houston volumes are now scanned and available online. These books constitute what historian Charles A. Bacarisse called "the bed-rock for a history of East Texas." Genealogists with early Texas ancestors should not consider their work complete if they have not consulted this collection.

Typed transcripts and translations made by Blake of official records and personal papers found in the Office of the County Clerk in Nacogdoches, in the Nacogdoches Archives, in the General Land Office of Texas, and in the University of Texas Archives (including the Bexar Archives). Included in the collection are legal papers, census records, jury verdicts, promissory notes, summonses, election returns, bills of sale for slaves, civil and criminal proceedings, and genealogical and historical material on East Texas subjects.
