September All Day Seminar

John Humphrey

On Saturday, September 18, 2004, Genealogy Friends presents award-winning author, John T. Humphrey.

John is the current president of the Mid-Atlantic Germanic Society and vice president of the Genealogical Society of Pennsylvania. Mr. Humphrey's principal genealogical publication is the fourteen-volume set of Pennsylvania Births that list more than 170,000 birth in eleven eastern Pennsylvania counties prior to 1800. He has written other books and numerous articles, lectures widely on German and colonial research, and has appeared on national television and public radio. He was the former director of the National Genealogical Society Learning Center. Currently Mr. Humphrey is working on genealogical records created during World War II of interest to researchers in Germany and the United States.

Topics will be:

Reconstructing Families on the Colonial Frontier - Records kept during the colonial period can be difficult to find or when they do exist, they are often incomplete causing serious obstacles to research. This lecture explores strategies to get around these obstacles by creatively using data found in the records that do exist.

Researching Pennyslvania Ancestors - If your ancestors are from the keystone state you need to know about Pennsylvania's deeds, warrants, patents, probate and vital records.

Researching German Ancestors: "The Agony and the Ecstacy" - This two hour introduction to German research explores obstacles like language and custom, and it looks at a variety of records kept by Germans both in the U.S. and Germany that will open the way to a rich source of research material.

Wills and Probate Records

Wills and probate records can provide evidence of family relationships as well as information to help us put our ancestors in the context of their lives.

If your ancestor died leaving a valid will they died testate. If your ancestor died without leaving a valid will they died intestate. States govern probate law so it is wise to investigate the laws in effect in the place where your ancestor died. If your ancestor owned real estate or had children of less than legal age, there were probate records generated even if they did not leave a will. Whether or not they still exist is a different point.

In a will a person may name their spouse and living children, however, for various reasons they may not be mentioned. If some of their children pre-deceased them, leaving living grand-children, they may also be mentioned. There may also be people mentioned who are not relatives. The will of Anton Wilke provided valuable information I had been seeking. In his will he mentions, not only his wife's maiden name but her two previous husbands and all the children by each marriage. His wife and her second husband were the parents of my Great-great Grandfather. I was able to locate the will because an abstract existed that included not only the names of the deceased but the executors/administrators. My Great-great Grandfather was named as the Executor in the will. Even if you don't recognize the name of the deceased, obtain the original document and read the entire text. The abstract did not even mention the wife's name, much less the information on her previous husbands.

If a person dies intestate all the heirs have to be identified based on the law of the state before the administrator can begin their tasks. This can provide invaluable clues, for times before vital records, this may be one of the few records that exist proving the relationship between a parent and child.

The probate process is similar in most states. First the Will is presented to the court and court admits it to probate, payment of fee and will is recorded. An administrator is appointed if an executor was not named in the will, an inventory is made, the property is disposed of often by a sale, obligations are paid, distributions to heirs are made based on the provisions of the will or the law of the state, and the final settlement papers are filed.

To find a probate record you will need to know the person's place of residence at the time of their death. If they resided in one place and the family resided in a different place, check both. Joseph Newsham grew up in Monroe County, Illinois. In 1849 he caught the gold fever bug and relocated to California. He died 10 years later in California, however, he still owned a piece of property in Monroe County and the rest of his family was still there. There is a probate file in Monroe County for Joseph. Often there is an index of probate records.

Normally you will find two types of probate records — records of the probate court and estate packets. The court records are a diary of what occurred in the court, whereas the estate packet usually contains all documents filed with the court pertaining to the inventory and disposition of your ancestors belongings. The estate packets can tell you many things about your ancestor. If they owned property, there may be a description of the property and receipts for any taxes paid or repairs made which were paid for by the estate.

Often in the estate packet you will find the records from the sale of property, both real estate and personal property. Pay attention to the people who purchase items especially things that would be family heirlooms or those that appear numerous times, they may be relatives.

If there are minor children a guardian will be named and there will be records generated including accounting of spending of the estate on the children's behalf which can provide interesting information about childhood illnesses, schools attended, etc.

The estate packet of John Newsham was extremely interesting. Family lore included a story about John, he lost his mind and died in a private hospital. John and his family lived in Macon County, Illinois. There is no death certificate, obituary, or will for John. However, his probate packet had been microfilmed by the Family History Library. John did not leave a will, therefore, all of his living heirs, his wife and children, were mentioned. Included in the packet was a receipt for John's care for the month leading up to his death at the Illinois Central Hospital for the Insane, the first hospital for the mentally ill in Illinois. I'm not sure how long

he was there but John was a resident when he died. Also included were the inventory, which indicated that his wife and children continued to operate the family farm in John's absence. I could tell by the descriptions what types of livestock they were razing and how many of each. The inventory also included items indicating that his wife or daughter was a seamstress. There was a description of the real estate he owned at the time of his death, so I was able to compare it to the land records I had to ensure I had all the records. The records proved the relationship between he and his children and provided details of their lives that weren't available in other places. Check out probate records and wills for your ancestors, you never know what you might find.
