## The Genealogy Proof Standard

As genealogists, our goal is to accurately reconstruct our ancestors' lives. The Genealogy Proof Standard (GPS) was developed by the Board of Certification of Genealogists in 2000 and refined in 2014. "Standards are best practices for genealogy" and aren't limited to professionals who are doing research for clients. Even those of us that are exploring our family history for our own pleasure should focus on quality research. "Standards enable all genealogists to come as close as possible to what actually happened in history."

To reach a sound conclusion, we need to meet all five components of the GPS:

- 1. Reasonably exhaustive research—A research plan focuses your search. Think about what records might answer your research question, determine if they exist for the place and time you are searching and locate them. Research guides, FamilySearch Wiki, and resources from local genealogical societies or institutions can help locate records.
  - Focusing only on Ancestry.com, Familysearch.org, or FindAGrave is not an exhaustive search. Not all records are online, you might need to visit an institution or hire a researcher to get more records. Reading journal articles about problems like the one you are researching or for the same area and time period is a great way to identify sources and learn about approaches for planning your research. Consulting fellow genealogists can help spur ideas; GenFriends meetings present the opportunity to do this.
- 2. Complete and accurate source citations—The most important reason to cite your sources is so you can locate the record or information again. There is nothing more frustrating than finding something in your files, needing more information about it and not remembering where you found it.
  - Citations also help others evaluate the sources you referenced in your research and tells others that you did complete, careful research. Think about the trees on Ancestry.com with no sources, how much do you rely on them? You don't want your research to be in that category.
- 3. Thorough analysis and correlation—It is important to review the records you find carefully to determine what they are telling you, don't just pick up one piece of information and move on.
  - Begin by evaluating the source you found—why was the record created, who created it, when was it created. If it isn't an original record do your best to find the original and review it. If you are using a published source, check to see if the author cited their sources. Make sure you understand any terms used in the record, you might need to refer to a legal or medical dictionary. Are you reading the handwriting accurately? Review other records written by the same person looking for words that you can read. Look at how letters are formed and sentences constructed. Are all of the records written in the same format? There are reference sources available to assist with reading old handwriting.
  - Compare this record to others you have found do they fit together. This step is critical if there are multiple people of the same name in the location your are searching. If your ancestor is missing from a source determine why. Are the records complete? Are there other sources that might have the same information?
- 4. Resolution of conflicting evidence—Compare the information you found to determine if there are any conflicts. If you find two records that don't agree you need to determine why. Is there a reason that one of the records might be incorrect? Is there a convincing reason why one record is accurate? Does the information fit with other information you found.
- 5. Soundly written conclusion based on the strongest evidence—Don't stop with searching and finding records. Research reports aren't just for professional researchers to present to their clients. There is great satisfaction in completing a project with a written conclusion. Writing a research report is how I review my search results for completeness, it helps me identify conflicting evidence, provides ideas for other sources to locate, and evaluate sources. When life gets in the way and I have to put my research aside for awhile, a carefully written research report helps me resume my research when things calm down and I can get back to genealogy. Sharing what you found is a great way to interest other family members and collaborate with other researchers. A website, blog post, family newsletter or writing an article for a genealogy society newsletter or quarterly are all options for sharing your research results and conclusions.

We spend a lot of time and energy on our family history, make the effort count by following the GPS.

### **Oldest Family in Frisco**

John Lenox Newman and his wife, Catherine, came to the Independent Republic of Texas in a covered wagon. In the 1840s, the Republic of Texas was offering Homesteads; this was before Texas became a state in December 1845. Homesteads were offered to anyone who would stay!

After the Newmans obtained a tract of land in an area that would later become Frisco, they camped in their covered wagon until a home could be built. There were no railroads yet, so supplies had to be brought in by wagon from a trading post (the current-day Dallas), which was several days' travel away from their land. Cedar Springs was the main campground for visitors to the trading post. The horses or mules could be fed and watered before their return to the Newman homestead.

Six children were born to John and Catherine, three girls and three boys. The girls, Margaret, Mary and Sarah, all married local boys, family names of White, St John, and Robertson. The two youngest boys, James and Stephen, died in their teens after swimming in the "Ole Newman Hole" which is now Lake Lewisville. It was thought that the boys died of 'The Fever'.

The oldest child, Nathan, married Martha Frances Cox who came from Pottscamp, Mississippi. They had only one child, James (Jim) Reeder Newman, who was just seven months old when Nathan died of blood poisoning as a result of an injury. Martha and her son lived with John Newman, and Martha cared for her father-in-law until his death in 1889. At that time, Martha and Jim inherited John Newman's blackland farm. She purchased another tract of land in the area and paid for it with things produced on the farm, such as butter and eggs.

After finishing his education in Waco and marrying Lula Neal from Lott, Texas, Jim returned to his home where they lived and cared for his mother. Jim Reeder Newton appreciated the value of good schools and teachers. He donated land and money to build a two-room schoolhouse, Robertson School, located west of Frisco near Highway 720 and what is now Twin Falls Road. (Previously Newman Road.) He also built the first brick house in Frisco, Texas. It is located at Fifth and Hickory Street. Construction began in 1914 and was completed in 1918; taking four years to build due to the scarcity of materials during World War I.

John Lenox Newton's descendants may be the oldest family still living in Frisco, Texas.
