# Timelines

Timelines are a great way to organize your research results, especially if you are a visual person. They make it really easy to see where the holes are in your research. You can use an excel spreadsheet or a table in a word document for a basic timeline.

I recently started a timeline to share my research with family members who aren't genealogists and got rave reviews. They were curious about what I had found but I'm not ready to share in book form yet this was a good interim step. The website I used is call The History Project. You can share your timelines with specific individuals, keep it private or make it public. Don't forget not to include info on living people especially if you are going to make the timeline public. It is easy to add events and you can upload documents, photos, add video or audio or links to other websites. If you tag your events with a location they appear on a map in your project. The map was a great visual to show the migration pattern of the Sennott family. ## AUTOSOMAL DNA TESTS ARE POWERFUL FOR FEMALES

Although DNA testing has been around for over 30 years, it is still evolving. Using it for testing for family matches is rather new. It is not just for the legal system to use anymore. To date, Ancestry.com/DNA has tested over two-million genealogists. They also have a 'chip' to use. I do not exactly understand how the chip will be used, but I am familiar with using a chip to find my dog if she escapes. We will have to wait and see. Ah, the mystery.

You must understand exactly what type of DNA test you need. If you are a guy, then a yDNA test is one test you can take that will show your paternal line and the maternal line. That is the ancestors of your father and mother. Females have two tests they can take. Previously, there was the



mtDNA or mitochondrial DNA test. It is limited to matching ancestors of your mother. It does not match the female DNA with the paternal or father's line.

Therefore, if you have a brick wall on your paternal side, you are dead in the water so to speak. I took the mtDNA test so many years ago with Oxford in England and with Family Tree DNA in Houston. That was all that was offered. However, my brick wall was on my father's side. I had verified the line through court records back to 1790 but I could not go further back. My closest paternal male cousins were dead, except the one I was not able to locate. My paternal male cousins have many beautiful female daughters, but so do I. I really was dead in the water since it was mostly females still living.

Then the aDNA or autosomal DNA test was available for testing through Ancestry.com/DNA. It tests because it looks at hundreds of thousands on the genome rather than the older tests that barely beyond the double-digit numbers. These look at around 600,000 sites, so when you read that it looks at only 3%, remember how huge this number really is. This new test can easily go back five generations, and more in some cases; however, they do not send you matches further than about five generations. Moreover, remember, those people in the database matching your DNA are getting matches also. You get all this for just supplying a saliva sample. How simple!

My cousin, the one with all the energy and intelligence, jumped at the chance to have her aDNA taken through Ancestry. Shortly afterwards, she received her emails giving her clues to people carrying her father's DNA. She began receiving several each week. Having an aDNA test is powerful! She became acquainted with cousin family historians she would never know about had she not tested her aDNA.

She talked with me and encouraged me to have my aDNA taken so that I could possibly break the brick wall. Knowing that she is right, but that knocking down one brick wall will probably lead to another, I told her that I would do it. My cousin's DNA results that match my results determine our research to date is valid. And, our matches will overlap.

I hope I have encouraged you all, male and female, to have your aDNA tested. This test is less expensive than the y or mtDNA, maybe in some cases by almost half. Ancestry markets aDNA for about \$99. It does have sales where you can test for \$77, or less. I am waiting on the next sale. It takes about ten days for the kit to arrive and about six to eight weeks for the results to arrive. In a couple more weeks, you will begin to receive lots of matches to cousins matching your DNA.

Ancestry has a site, *AncestryDNA—Frequently Asked Questions*, that you might want to access. It is at <u>https://dna.ancestry.com/en/legal/us/faq</u>. It explains how to understand DNA, interpret results, download your data, your ethnicity, how Ancestry results differ from other companies and DNA privacy. That said, I will probably let that energetic and intelligent cousin of mine be my Administrator.
